

## Summer I 2025 IMPORTANT PAYMENT INFORMATION Tuition Payment Deadline – Wednesday, May 28, 2025

<u>Tuition and Fee</u> billing is an automated, electronic process driven by student registration transactions. All student account information and billing statements are available electronically through Self-Service. Notifications of e-statements are issued to the student's official College email. **Students are required to monitor their school email account regularly.** 

**Summer I 2025 course registration creates financial responsibility for tuition and fees.** Financial clearance of your student account must be achieved by the tuition payment deadline through one or more of the options listed below.

Registration will be accepted after the payment deadline; payment must be made at the time of registration (unless charges are otherwise covered by one of the options listed below). If you choose not to take class(es), you must officially drop your class(es). Please refer to the College Catalog or contact the Registrar's Office for information on how to drop classes or withdraw. You should also refer to the College's Official Refund Policy for details on refunds for dropped courses or complete withdrawals during the refund period. Please note that if you do not drop your class(es), you will remain responsible for all charges!

ONLINE TUITION PAYMENT PLAN	Enroll online via <a href="https://commerce.cashnet.com/luzernepay">https://commerce.cashnet.com/luzernepay</a> .  Depending on the plan selected, payment equal to 33-50 percent of total tuition and fees is due at the time of enrollment. Future installments may be pre-scheduled using a saved payment method.	Additional installment due dates are thirty days after the initial payment. A \$35 enrollment fee will be assessed. Late fees and returned payment fees also apply.
FINANCIAL AID AWARD	Secure financial aid to cover your balance. Any balance not covered by financial aid is due by the payment deadline. In order to use financial aid to satisfy charges for Summer 2025, make sure you complete and submit the 24-25 Free Application for Federal Student Aid (FAFSA), your Summer financial aid application, and any other requested documents to the Financial Aid office in a timely manner. THIRD-PARTY SPONSORSHIP	Secure a third-party sponsorship and submit the completed form by the payment deadline. Any balance not covered by sponsorship is due by the tuition payment deadline. Proof of eligibility is required for CareerLink, OVR, or Job Corps before the payment deadline. Contact your sponsor to get an authorization letter or clearance form and complete the College Application for Employer Tuition Reimbursement. MILITARY AND VETERAN FUNDING	Veterans, service members, and families using the GI Bill or Military Tuition Assistance must contact the Financial Aid Office. If this funding does not cover the full cost, any balance due must be paid (or the payment plan enrollment completed) by the payment deadline.
